2022 key votes

Vanguard's Investment Stewardship team conducts voting activities on behalf of the Vanguard-advised funds¹ in accordance with each fund's board-approved voting policies. The funds' votes are an important opportunity to safeguard the interests of long-term investors. The tables on the following pages detail select proxy votes by the funds for the 12 months ended December 31, 2022.

Vanguard identified these proxy votes based on criteria that Vanguard uses to identify a "significant vote" for the purposes of the Shareholder Rights Directive II, a European Union directive that aims to improve corporate governance. We highlight these proposals because they (i) involved a vote at a company in

which Vanguard holds a meaningful ownership position, (ii) conveyed our perspective on an important governance topic elevated during the proxy season, or (iii) communicated our view of progress—or lack thereof—by a company and its board. In some instances, more than one proposal at a given company meeting is included. In the "Proposal type" column, an M denotes a management proposal, and an S denotes a shareholder proposal.

Highlighting these votes and their rationale is part of our effort to provide investors and other interested parties with a clear understanding of Vanguard's investment stewardship activities on behalf of our funds.
